Please note: If you took this training previously, it is current for 3 full years. If you are new to the Farmers' Market Nutrition Program (FMNP) the Senior Farmers' Market Nutrition Program (SFMNP) or the WIC Fruit & Vegetable Check Program (FVC), **or took training prior to 2013**, you are required to attend a session to participate in the program this market season. Once you have completed the training it is good for 3 years.
