DIRECTIONS

From Baltimore:

Take I-97 toward Annapolis. Continue until I-97 merges into US 50 East. Take first exit, #22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters on the right.

From Washington:

Take US 50 toward Annapolis. Take Exit 22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters.

From the Eastern Shore:

Take US 50 to Exit 22 (MD 665) to Riva Road. Turn right on Riva Road and continue for two lights to Harry S. Truman Parkway. Turn right and proceed one-half mile to MDA headquarters.
