The Grain Dealers Law is designed to provide limited financial protection to grain producers. Persons receiving, storing or buying grain from grain producers are required to obtain a license from the Maryland Department of Agriculture annually. Farmers purchasing grain for use in their farming operations are exempt. The requirements for obtaining a license include documentation of a minimum net worth and certification of insurance to cover the grain stored. The requirements for obtaining a Grain Dealers License do not guarantee payment for the producers. However, they do reduce the risk by ensuring that licensed grain dealers have demonstrated minimal financial stability and proof of insurance.
