Federal Register / Vol. 85, No. 185 / Wednesday, September 23, 2020 / Proposed Rules

1. "The rule also would help establish a foundation for the use of consistent food tracing terminology, a **transition from paper-based recordkeeping to electronic records**, and a universal understanding of the critical information needed for a standardized and efficient system for traceability."
2. "...assign a traceability lot code **when** they originate, transform, or create a food on the Food Traceability List."
3. "Proposed § 1.1330(c) would require a **first receiver of a food on the Food Traceability List** to which the originator of the food has not assigned a traceability lot code to establish a traceability lot code for the food and maintain a record of the traceability lot code."
4. "Most firms can provide information about what lots of product were available for potential use during the transformation or manufacturing process. However, some firms currently lack the ability to connect the finished transformed product to its ingredients and the amount of each ingredient lot used during the transformation... and the date(s) and time(s) of harvesting."
5. "Proposed § 1.1455(a)(2) would require that all **records be legible**."
6. "We would only request the specified **spreadsheet when we conclude** that obtaining the information in this format is necessary to help us prevent or mitigate a foodborne illness outbreak, assist in implementation of a recall, or address a credible threat of serious adverse health consequences or death due to an adulterated or misbranded food."
