2. Check in for taking the exams is from 9:00 A.M. - 11:00 A.M. of the day listed for each location.
3. Individuals have until 3:00 P.M. to finish taking the exams.
4. Cell phones and other electronic devices, except for a calculator, are not allowed in the exam room.
5. There is a \$10 fee for each reexamination, payable by check, cash, or money order due at the exam session. (Public agency certification applicants are exempt from the fee.)
