ALL APPLICATIONS MUST BE POSTMARKED BY THE CUT OFF DATE IN ORDER TO QUALIFY TO TAKE THE EXAM THE FOLLOWING MONTH

1. Applicant must bring Examination Notice Letter and valid ID (Driver’s License).
2. Check in for the Exam is from 9-11AM of the day listed for each exam location.
3. Individuals must be finished taking all exams prior to 3PM.
4. **CELL PHONES & SMART WATCHES AND OTHER ELECTRONIC DEVICES (EXCEPT FOR A CALCULATOR) ARE NOT ALLOWED IN THE EXAM ROOM.**
5. There is a \$10 fee for each reexamination, payable by check, cash, or money order ONLY and is due at the time of the exam. (Public Agencies are exempt from this fee)
6. Failure to follow all the above directions may result in exam failure or prohibition of testing.
