### Cover Crop Fact Sheet | Clover (Only as Part of Mix)

Clover (*Trifolium*) is a perennial legume that is added to a cover crop mix (50/50 or 50/25/25) and used to protect soil from erosion, suppress weeds, fight disease, and fix nitrogen. When a mix is used, the crop with the earliest planting date will determine the planting deadline. All mixes must contain a cereal grain representing 50% of the mix.

#### Seeding Rates, Planting Dates, and Payment Options

<b>Aerial-</b> airplane, helicopter, drone, or ground-driven apparatus	13	6	Oct 10	\$50/ac
<b>No-till or Incorporated</b>	8	4	Oct 10	\$65/ac
<b>BCSC</b> (Broadcast/stalk chopping)	13	6	Oct 10	\$50/ac
<b>BCCP</b> (Broadcast/cultipacker)	13	6	Oct 10	\$50/ac
<b>Fall Applied Non-Poultry Manure</b>			Oct 10	\$25/ac

#### Eligible Planting Methods

<b>No-till</b>	Use a no-till drill in undisturbed ground
<b>Conventional</b>	Prepare seedbed using tillage (plow, chisel, or disk), then drill the seed
<b>Broadcasting with Light Tillage</b>	Broadcast seed followed by light disking or a similar method to ensure seed-to-soil contact
<b>Aerial Seeding-</b> airplane, helicopter, drone, or ground-driven apparatus	Seed into a <b>standing</b> approved previous crop, and must use the aerial seeding rate
<b>BCSC</b>	Broadcast seed followed by stalk chopping (corn or sorghum only).
<b>BCCP</b>	Broadcast seed followed by cult packing (corn or sorghum only)

#### Fall Reporting Requirements

- A. Report planting to SCD within 1 week of completion
- B. Submit signed seed tags, seed tests, and/or aerial invoices for each species planted
- C. The deadline to submit fall documentation is **December 1**
- D. A partial payment for your cover crop is available in the fall upon request.

#### Spring Reporting Requirements

- A. Termination may begin after **March 1**
- B. Applicants are encouraged to delay termination until the flowering stage to get the most benefit
- C. Termination should be reported within 2 weeks of completion and by **June 1**
- D. All acres Fall certified must be reported in the Spring
- E. Spring claim will be issued based on acres spring certified minus any fall payment
- F. The Spring payment will be processed after the final satellite imagery review and by July 1
