Final Minutes February 15, 2024

Amy Posey, Acting Chair, called the meeting to order at 9:32 a.m.

Discussions

Alisha Mulkey, SSCC, reviewed information received from several Districts regarding their role in the enforcement of Maryland's certified sod laws. As a reminder, the Maryland sod industry is experiencing hardship when Maryland certified sod is not being installed at development sites, as required by state law. The issue has been elevated to MDA leadership and the Ag Commission, and a request was made for the SSCC to consider the role (if any) of SCDs in the enforcement process for certified sod. Based on feedback from several Districts, the enforcement authority and inspection duties generally lie with MDE or the county. However, some Districts do hold pre-construction site meetings and use this opportunity to review requirements from MDE's 2011 E&S manual, which includes specifications and standards for certified sod installation. Districts are encouraged to coordinate with the respective authority in their county to remind them of the requirements for state certified sod. An example checklist is available from Frederick County. Alisha will provide follow up materials to the Districts, including the relevant state laws for the production of certified sod and the 2011 E&S manual with relevant sections.

<u>Michael Mason, Providence Strategies,</u> reviewed relevant legislation to-date in the 2024 Maryland session. Over 2000 bills have been filed at this time between the House and Senate. Michael reviewed the economic outlook for the state that is influencing budget decisions, and talked through the following bills of key interest to the Districts:

- House Bill 991 | Senate Bill 1074 Environment Industrial Sludge Utilization Permit -Establishment
- House Bill 1017 Boundary of the Frederick Soil Conservation District Alteration
- House Bill 1320 (new) would change the Bay Restoration Fund funding level provided to MDA's Cover Crop program from a percentage annually (current) to "an amount equal to FY24" (proposed)

Reports

<u>Hans Schmidt, MDA</u> reported a busy 2024 legislative session is underway. MDA is monitoring over 100 bills. The state's tight economic outlook means legislators are seeking to shift funds for new program uses.

Nutrient Management, in consultation with UMD, will allow top dressing of small grains to begin. The Cover Crop TAC will meet March 6 at MDA. Each region is being asked to send 1 rep only. MDA's hearing on the Operating Budget was recently held and it went well. The Capital Budget hearing is next week.

Sec. Atticks is chairing an Ag Action Team for the Chesapeake Bay Program. The Action Team will consider the need and role of an Ag Advisory Committee to be established.

A call for volunteers for the HPAI team has been released.

Rob Feldt, DNR reported a new Associate Director for the 5M Tree Initiative has been hired. The department is seeking to partner with NRCS on site index reviews for buffer plantings to better discern variable buffer width needs.

DNR continues to make progress toward tree planting goals, but is not pursuing prime aglands or revoking agland leases.

<u>Jim George, MDE</u> reported a concern from the air quality administration at MDE about mortality incinerators being present on farms without permits.

<u>Darren Jarboe, UM Extension</u> reported The University of Maryland Statewide Extension Advisory Council (SEAC) met virtually on February 13 to discuss unmet needs and opportunities, strategic partnerships, and UME program priorities for the next five years. The next SEAC meeting will be October 8. University of Maryland Eastern Shore and University of Maryland, College Park had their semiannual meeting to share applied research and educational programs, coordinate Extension efforts, and identify collaboration opportunities.

Dr. Xuan Wei started as urban agriculture farm and agribusiness management specialist on February 12. Dr. Qianwen Lu will start as urban agriculture production specialist in mid-March. Both have statewide responsibilities and will be located at CMREC-Clarksville.

The Agricultural Nutrient Management Program (ANMP) has received requests for 723 nutrient management plans and 40% of these have been completed. All the information needed to write nutrient management plans has been received for 58% of the requests and 69% of these have been delivered to farmers.

LEAD Maryland Class XII visited Panama in February for its international experience. Class XIII starts its program on February 22 in Cecil County. LEAD Maryland will celebrate its 25th anniversary that day. The AgFS Program has 10 positions in various stages of recruitment. Charles County AgFS educator candidates have been selected for initial interviews. The AgFS vegetable production specialist and

ruminant livestock specialist positions are expected to post on eTerp around March 1. The Caroline County AgFS educator position description has been submitted to human resources and will post in late spring. The faculty specialist, ANMP program director announcement is accepting applications and has a best consideration date of February 18. Sixteen applications were received for the five open nutrient management advisor positions in Caroline, Montgomery, Wicomico/Worcester, and Washington Counties, and statewide. Nine of the candidates will be interviewed in late February or early March. AgFS winter educational programing continues.

<u>Suzy Daubert, NRCS</u> reported USDA has released a new tool to support TSPs writing Nutrient Management Plans. She will reach out to UM Extension and MDA to review the tool. USDA has announced creation of a Climate Corps nationally.

Several Districts have experienced connection issues with Conservation Desktop (CD). The national office is reviewing these for network issues in the office, but in the interim it is recommended avoiding MS Teams use while also trying to access CD.

Bob Wevodau for FSA, reported the 2018 Farm Bill has been extended through September 30. Staff are waiting to hear about new program guidance.

March 15 is the ARC PLC deadline.

Signup for the dairy margin coverage program will open soon.

CRP is open for new offers, and CREP re-enrollment offers are underway.

John Swaine, MASCD reported the winter meeting will be held February 22-23 in Annapolis.

The next BOD meeting will be March 26 and MASCD annual meeting July 8-10.

The NACD fly-in will be March 20.

- The District Manager position will be having interviews soon.
- Calvert SCD Cooperator of the Year Dinner will be on March 21st.

- Envirothon training was held on February 6th.
- Charles SCD's annual dinner will be held on May 22nd
- Charles SCD's grant-funded planner attended the NACD annual meeting in San Diego.

Prince George's:

- The PGSCD Annual Cooperator Dinner will be held on April 19th. Invitations will be sent in mid-March.
- PGSD attended the Delmarva Soil Summit, PGSCD encourages every SCD in MD to attend when it comes back around in 2026.
- PGSCD is moving ahead with the 5-year USDA Climate Smart Commodities grant. Prince George's Dept of Environment is the grant recipient. PGSCD, UM Extension, PG Food Equity Council, and Bowie State College are partners on the grant.
- This month PGSCD will begin working with a second group of UM College Park seniors from the School of Information Sciences on a capstone project mapping ponds in the rural farm area. The first round of mapping was completed last semester and identified 80 ponds in two of our prominent farming (four-digit) watersheds.
- The PGSCD Urban Development section has been conducting bi-weekly pre-submission meetings with several of the largest engineering consultants in an attempt to reduce the number

- of submissions it takes to get approval for Concept, Environmental, and Final Erosion and sediment control plans.
- PGSCD is now accepting electronic payments and electronic plan submissions.
- Plan to conduct our second "Round table discussion on land use processes" in late April or early May, following legislation session and our annual dinner.

St. Mary's:

- The St. Mary's SCD 69th annual Cooperator's dinner will be held on Friday, February 23, 2024 at the Bay District VFD in Lexington Park. Reservations are due on Friday, February 16, 2024.
- District staff will participate in the annual Easter Festival at the Leonardtown Fairgrounds on Saturday, March 23, 2024. The District will be popping and selling Kettle corn for the local Envirothon program.
