University of Maryland Extension – Darren Jarboe:

The University of Maryland (UMD) is transitioning to a new administrative system called Workday. The transition will take place November 15.

The University of Maryland Extension is embarking on a strategic planning process to develop a stakeholder-driven plan, granting the university's faculty, staff, students, leadership, and community partners an opportunity to contribute to the institution's future success. To produce a specialized plan that is consistent with the broader objectives of the University of Maryland, we will prioritize strategies that will uplift our community and complement UMD initiatives. So far, we have engaged the Emergent Method to help us facilitate the process. We have started assembling data for desk research + data analysis, leveraging self-study and accreditation materials. We also developed an initial project plan and stakeholder engagement plan (including interviews, listening sessions, and town hall meetings). Our goal is to collect as many diverse perspectives and viewpoints as possible. We established a strategic planning steering committee and had a kick-off meeting on September 18. As we progress through the planning process, we will routinely update the website with status updates and information on engagement opportunities. More details on the website will follow very soon.

Last weekend Stanton Gill passed away suddenly. He was a long-time IPM specialist with the Agriculture and Food Systems (AgFS) Extension Program in Maryland. Stanton's leadership of the ornamental horticulture team led to a high performing, collegial team that served Maryland, the Mid-Atlantic Region, and national horticulture industries. The team has been driving innovation through applied research and demonstration programs. Stanton always looked for ways to involve new Extension faculty members in research and educational programming, making them feel welcome and part of The AgFS Extension team. He will be missed by the AgFS Team, University of Maryland Extension, and the ornamental horticulture industry.

The AgFS Program has nine open positions. The Caroline County AgFS educator position was reopened for recruitment of candidates and initial screening is underway. Initial interviews are being arranged for the new faculty specialist for local foods and entrepreneurship position.

The ANMP program director position and faculty specialist positions will be reopened after UMD transitions to Workday. The nutrient management advisor interviews have taken place for the positions in Anne Arundel, Carroll, and Charles Counties and references have been requested. The search for a Washington County nutrient management advisor will be extended. The ANMP administrative assistant position closed October 14 and interviews will be set up soon.

Craig Yohn, nutrient management advisor, Dorchester County and past interim ANMP program director, announced his retirement from the ANMP effective October 31, 2024. Craig provided excellent service to his farmer clientele and his excellent nutrient management knowledge and expertise will be missed.

Sandy Corridon, interim program leader for 4-H Youth Development and Dr. Jeff Howard has taken over the role of interim program leader for 4-H Youth Development. Patsy Ezell, interim program leader for Family and Consumer Sciences Extension, has retired again and Dr. Lisa McCoy has stepped into the interim FCS program leader role.

MASCD – John Swaine:

Maryland Bay-Friendly Farming Program (Maryland BFF) Updates

- National Fish and Wildlife Foundation has determined that MASCD is required to have a Quality Assurance Project Plan, or QAPP, prior to conducting field assessments funded under our grant. NFWF works with a 3rd party contractor to provide guidance for completing the QAPP, but this requirement will delay the start of the project while we develop the plan and submit it to EPA for approval.
- MASCD conducted a field evaluation of a farm together with MDA and NRCS on 9/20. The purpose of the group evaluation was to 1) see how the Maryland BFF evaluation compares to a CSP evaluation with NRCS and 2) to ensure that all members of the partnership have a clear and common understanding of the evaluation criteria and expectations.
- Letters have been sent to farmers formerly certified under the Farm Stewardship Certification and Assessment Program (FSCAP) to let them know about the rebranding to Maryland BFF and to offer the opportunity to be recertified through the new program.
- Keith Campbell Foundation- MASCD has submitted a proposal to support the development of a media plan to promote the program. KR Creative Strategies (the same firm that we worked with on the Maryland BFF rebranding) has developed a proposal for our consideration if MASCD receives the funding.

Other Grants & Funding

- **NRCS Agreement Update-** MASCD has signed an agreement with NRCS to develop a new agreement for FY25 to fund administrative support in Caroline, Talbot and Kent counties, and a program support specialist in Queen Anne's County. The new agreement provides \$1,381,078.96 to fund the positions for the next five years.
- **Keith Campbell Foundation Proposals-** MASCD has also submitted a proposal to the Keith Campbell Foundation to continue our Leadership Development Initiative to

support the development of governance documents for districts and provide the opportunity for additional training for managers.

Other

 Association of Conservation Executive Directors Conference in Manhattan, Kansas from September 30 – October 3. This annual meeting of state association executive directors is a really good opportunity to share innovative projects and programs, and to compare notes on policy, budgets and challenges. For example, challenges in working with FPAC on leasing issues and agreement issues are universal across the country, although the staff size varies a lot between states and affects the capacity of each state to manage those challenges.

The group also learned about water rights easement programs in Kansas, and toured a training farm for veterans, the Kansas Wheat Innovation Center and the Koza Prairie Biological Station, where scientists are studying ecological outcomes associated with burn schedules and bison grazing patterns.

- Rotary Clubs and NACD- NACD has been having discussions with leadership at Rotary to explore partnership options. Rotary Clubs have added "Environment" as a new area of focus for their organization and are looking at the conservation districts as potential partners in offering volunteers and fundraising support.
