

## Maryland Department of Agriculture **Tree Incentive Guidance**

Beginning April 1, 2023, new MACS projects with certain conservation practices may be eligible for a tree incentive payment on top of the cost-share provided for in the agreement. The incentive is \$2 per tree.

The eligible practices are:

- Windbreak Establishment (380)
- Silvopasture (381)
- Riparian Forest Buffer (391)
- Hedgerow Planting (422)
- Tree and Shrub Establishment (612)

The incentive payment is available for any new trees that are planted as a component of the practice, and will be paid to the participant after the following has occurred:

- A claim for payment for the eligible practice has been submitted and approved by MACS.
- The form, *Bonus Incentive Payment for Conservation Grant Programs* has been completed and submitted to the Conservation Grants office.

The *Bonus Incentive* form will be mailed to the participant with their MACS project approval letter. Much of the information on the form will be pre-filled in by the Conservation Grants office; however, the dollar amount of the payment cannot be determined until the practice is complete.

The SCD will complete the form for the participant while they are completing the claim for payment. The number of trees actually planted, and the calculated incentive payment will be filled in at that time. Note that this incentive is based on the **number of trees planted**, not the acres of the practice. The participant must read and sign the *Bonus Incentive* agreement. The form will be returned to MACS with the claim for payment.

The participant should be made aware that the tree-planting incentive payment may arrive separately from the MACS cost-share due to different funding sources.
