Orals* vs Final Orals** and Total Scores

- During the preliminary Oral Presentation round, teams give a 20-minute presentation on a real-world scenario to a panel of judges for a score (*Orals*). This score is then added to scores from the 5 stations tests taken by the team. The combined total determines the top 3 overall scoring teams that advance on to the final Oral Presentation round of the competition.
- During the final Oral Presentation round, the top 3 teams re-present their Oral Presentation to a new panel of judges for a final Oral Presentation Score. Team placement for 1st, 2nd, and 3rd is determined by adding the five station test scores to the new final Oral Presentation score (*Orals Final*). The preliminary score is dropped and not used to determine team placement in the final round for the top three teams.
