

FARMER TRAINING & CERTIFICATION ONLINE For Agronomic Crop and Animal Operations Spring 2024: April 1st-May 3rd "Write Your Own Nutrient Management Plan"



Description: An opportunity for producers with cropland and pastures in Maryland who use commercial fertilizer and/or manure to learn how to write nutrient management plans (NMPs) for their operation that meet Maryland Department of Agriculture's regulations.

<u>Please Advise:</u> The course requires a minimum time commitment of 15-20 hours over 5 weeks. Larger, more complicated farm operations and those with high phosphorus soil test levels may require additional training and a larger time commitment. *Farmers should have soil and manure analyses prior to the second week of training.*
