Maryland Department of Agriculture Spay and Neuter Grants Program ANNUAL REPORT August 2021 (July 1, 2020 – June 30, 2021)

This report details the activities and accomplishments of each element pertaining to the Maryland Spay and Neuter Grants Program for FY21 covering July 1, 2020 to June 30, 2021.

The end of FY21 marks the close of the seventh year of funding for the Spay and Neuter Grants Program. As of June 30, 2021, the program has funded 183 programs that have provided 80,216 spay and neuter surgeries for dogs and cats of low-income families as well as feral cats.

The beginning of FY21 saw many of the projects and veterinarians working to catch up with a backlog of appointments from the April 1–May 7, 2020 project held due to the COVID-19 pandemic. Based on the veterinary board recommendations to make most spay and neuter surgeries non-emergency procedures to help promote social distancing and to allow for PPE to be used in hospitals during the global shortage, the Spay and Neuter Program had placed a hold on all grant activities. This hold came in the late spring, which is typically one of the most active times of year for feral cat breeding and Trap Neuter Release (TNR) efforts. Throughout the year, veterinary clinics have been beyond capacity with appointments and backlogs for spay and neuter services. Some county shelters that were hit the hardest by COVID-19 remained closed to the public for several months past mandated closures.

GRANT PROPOSALS SELECTED

FY21 Funding Cycle:

For the FY21 funding cycle, the Maryland Department of Agriculture (MDA) received 32 applications with a combined request of \$1,124,788.69. The grant application acceptance period opened on Jan. 10, 2020 and was originally slated to close on April 3, 2020. Due to the closures and changes that needed to be made for public safety in all public facilities by COVID-19, it was decided on March 18, 2020 to extend the deadline for the FY21 grant applications until May 1, 2020. This was to allow animal shelters and rescue groups to focus on changing their policies and practices to adhere to public safety guidelines as the guidelines for the pandemic were being implemented. All of the grant applications were carefully reviewed by the Spay and Neuter Advisory Board (SNAB) and MDA through the rest of FY20 and into FY21. Due to the delays caused by COVID-19, the SNAB was not able to meet until October 9, 2020 (the review board meeting normally occurs in the July/August timeframe). The SNAB selected the following applications to recommend for funding. These recommendations were accepted by the Maryland Secretary of Agriculture Joseph Bartenfelder on October 22, 2020.



The following table summarizes the funded application. They are in order of ranking based on the average cumulative scores by the SNAB.

Accomplishments for FY18 Funding Cycle Projects through FY21:

- By June 30, 2021, all 28 of the FY18 funded projects were completed. ¹
- Of the 28 completed projects, 21 projects (75% of the total projects) either met their target number of surgeries or exceeded their targets, four projects completed more than 90% of their original target; one project completed with more than 85% of its target number of surgeries, and three projects were unable to complete and returned the remaining funding.
- As of the close of FY21, 14,350 spay/neuter procedures were completed, exceeding the expected total by 3%.

Accomplishments for FY19 Funding Cycle Projects through FY21:

- All 36 of the approved projects were completed.
- Of the 36 completed projects, 30 projects (83% of the total projects) either met their target number of surgeries or exceeded their targets, four projects completed more than 90% of their original target, two projects were able to complete 75% of their target surgeries but were not able to complete their projects and returned the remaining funds to MDA.
- As of the close of FY21, 16,940 of the 16,364 proposed spay/neuter surgeries (103.5%) were completed.

Accomplishments for FY20 Funding Cycle Projects through FY21:

- All 30 of the approved projects were launched.
- 26 of the 29 projects have been completed.
- Of the 26 completed projects, 21 projects (72% of the total projects) either met their target number of surgeries or exceeded their targets, five projects completed over 90% of their target surgeries, and one project completed more than 85% of their target number of surgeries.
- The three remaining active projects are currently operating on a grant extension into FY22.
- As of the close of FY21, 15,036 of the 15,263 proposed spay/neuter surgeries (98%) have been completed.

¹ The approved application to the Caroline County Humane Society (CCHS) for \$37,357.00 was ultimately rescinded by mutual consent between MDA and the grantee. A change in management occurred just after the application's approval. The CCHS decided to focus on their active FY17 project to become acquainted with the MDA grant requirements, not accept the FY18 award, and instead reapply in FY19. The funds earmarked for this FY18 award were added back into the program budget for allocation to FY19 projects.



Applications for FY21 Funding Cycle:

- The Spay and Neuter Program sought applications for the FY21 Funding Cycle starting January 10, 2020 and ending April 3, 2020. Due to the COVID-19 pandemic it was decided to allow one additional month for applicants to submit their applications so they could focus on making adjustments to operating procedures during the closure.
- 32 applications were received and of those 29 were selected for funding.
- 28 of the approved 29 projects have been initiated.
- One of the approved projects will begin upon the completion of the FY20 grant.
- One of the initiated projects has completed and performed more than 100% of its total proposed surgeries.

Goals for FY20:

- Have the first virtual SNAB meeting to make funding recommendations from the applications received for FY21.
- Solicit applications for FY22 funding in January 2021.
- Make every effort to complete the review and approval process of the FY21 applications before the end of FY21.

Accomplishments by Funding Cycle as of the Close of FY19:

- The cumulative target number of surgeries proposed by funded projects from all seven funding cycles thus far is 86,515 procedures. As of the end of the fiscal year 80,216 or 92.7% of the total target number of surgeries were completed. This number includes the 31 active projects that are not yet complete.
- Of the FY15-19 cycles (those where all projects are considered complete), FY15 cycle resulted in 5,133 procedures out of the 5,340 cumulative target procedures (96.1%), FY16 resulted in 8,267 procedures out of the 8,281 cumulative target procedures (99.8%), FY17 resulted in 13,654 procedures out of the 12,863 cumulative target procedures (106.15%), FY18 resulted in 14,350 procedures out of the 13,944 projected (102.9%), and FY19 resulted in 16,940 procedures out of the 16,364 projected (103.5%).
- Of the two funding cycles still with active projects at the close of the fiscal year, FY20 cycle projects have completed 15,036 surgeries (98.5% of the 15,263 procedures targeted) with three projects still to be completed in the coming fiscal year, and the FY21 cycle has thus far completed 6,836 of the proposed 14,460 procedures (or 47.3% of the target) with 28 projects still active at the close of the fiscal year.

Goals for FY21:

- Close out the three remaining active projects in the FY20 cycle.
- Continue managing the FY21 projects cycle.
- Fund as many projects as possible from the pool of FY22 cycle applications under review in August 2021.
- Provide oversight for all projects to ensure funds are dispersed to grantees as per each project schedule, that all reports and related project obligations are met, and to offer assistance and guidance to all project managers to help them reach or exceed their goals.



PUBLIC EDUCATION AND OUTREACH

The following summarizes the outreach efforts put forth with regards to the Spay and Neuter Program during the fiscal year.

Accomplishments for FY21:

- The SNAB met one time during FY21 to discuss funding for FY21 projects (October 11, 2020). This was the first time that the board met online due to COVID-19. Meetings were advertised on the MDA website two weeks prior to the meeting and distributed to the media by the MDA's Public Information Office. Attendees from the general public were welcome ,but none were in attendance.
- Program announcements were made on the department's website, on MDA's social media accounts (Twitter and Facebook), and on the program webpage.
- The program webpage is located on the department's website and is the main repository for all documents, materials, and information relating to the Spay and Neuter Grants Program. The program coordinator updated this webpage with additional information and materials. In addition, other helpful materials and information were added to the webpage to benefit grantees and the general public.
 - There were 29,899 visits to the Spay and Neuter Program website in FY20.
- While the program normally produces materials to advertise the program through giveaways at the Maryland State Fair and other conferences, due to COVID-19, no materials were ordered in FY21 to be given away and no public events were attended or staffed.
- Each funded project performs outreach and education, not only about the services provided through their grants, but important general information about the need and benefits from the spay and neuter of pets and unowned cats and where to find help, additional information, and resources.

Goals for FY22:

- Continue to promote the program through all media available.
- Explore the idea of a conference or grantee forum where applicants and potential applicants can share ideas, methods, and experiences.
- Explore the idea of presenting at national conferences such as the Humane Society of the United States Animal Care Expo.
- Look for new ideas and materials to promote the program to the public and potential applicants.



ADVISORY BOARD

The Maryland Secretary of Agriculture appointed the seven-member SNAB on Nov. 7, 2013. The board was tasked to make recommendations on the program guidelines and regulations needed to implement the state's Spay and Neuter Fund and each cycle, make funding recommendations to the secretary.

Accomplishments for FY21:

- From the program's start in 2013, and each year following, the goal of the SNAB and MDA has been to make each element of the program the best it could be. Each year materials were developed, updated and improved. Likewise, methods for reviewing and evaluating each application period were refined. In the past, this necessitated multiple meetings of the SNAB and MDA to discuss and develop improvements. In FY21, it was decided that due to COVID-19 the program would not make any changes to the existing applications.
- During May through October 2020, SNAB carefully reviewed all 32 grant applications for FY21 funding. In anticipation of the formal review meeting, which was held August 11, 2021, each reviewer conducted their independent evaluations, and provided them to the program coordinator. These scores were used to rank the 32 applications to facilitate the discussion and help the board formulate funding recommendations that were submitted to the Secretary of Agriculture.
- Due to the closure of all PetValu stores in the United States, Kimberly Skillman was forced to resign from the SNAB as the pet food industry representative on March 16, 2021.
- On June 24, 2021 Morgan Beach of the Pet Food Institute was appointed to the SNAB to represent the interests of the Pet Food Industry.

Goals for FY22:

- Continue to strive for efficiency in the program and the processes.
- The FY22 grant application review meeting is scheduled for August 11, 2021.

DEVELOPMENT OF PROGRAM ELEMENTS AND MATERIALS

Accomplishments for FY21:

- No changes were made to the existing program materials to make the application process easier and keep it familiar to the applications.
- In FY21 the program coordinator (Nathaniel Boan) began working with the Enovational team to onboard the program with the online portal and do a complete overhaul of how forms and documents are gathered and shared. It is anticipated that in the FY23 grant application cycle, all applications will be submitted through the portal. The program will also be able to



process quarterly grant reports, quarterly shelter statistics, and grant agreements through the portal.

Goals for FY22:

- Improve, if needed, all applications and guidance.
- Continue posting final reports from projects as completed, update program map, and update project list.
- Continue to explore and develop new tools for applicants and project managers.
- Continue working with Enovational to finalize the FY23 grant applications to be processed through the portal.

FEE COLLECTION

The Spay and Neuter Program is funded from annual fees levied on manufacturers of all dog and cat feed and treats registered with the MDA Maryland State Chemist Office. The following lists the accomplishments in fee collection during this period. By law, the program must invoice registrants for the annual fee during the first week of October, and payments, whether made immediately or any time subsequent to the invoice date, are good only until the following October. The registrants are asked to review the invoice and product list on which the fee was calculated. They were instructed to delete any products no longer sold in Maryland or did not meet the definition of "cat or dog feed or treat" or add any new products that may have been missing from the list.

Accomplishments during FY21:

- The program coordinator requested that the Maryland Department of Information Technology (DoIT) generate the invoices and, based on what was received, sent 230 invoices for Spay and Neuter Program fees to feed/treat manufacturers, based on product information from the State Chemist products registration database.
 - Each invoice was sent via first class U.S. mail and included an explanatory letter, a list of products on which the invoice total was based, and instructions as to where to send the payment. The total number of products invoiced were 9,638.
- The program coordinator maintained a Program Fee Excel Spreadsheet that served as the main repository of fee remittance information. The coordinator maintained all paperwork pertaining to each paid invoice.
- The program coordinator sent second notices and third notices (certified mail to U.S. companies and registered to overseas companies) to delinquent accounts from 2019 invoicing.
- From the 2019-2020 invoicing cycle, of the invoices sent, a total of \$943,000.00 was collected as of June 30, 2020.
- Of the invoices sent, 16 invoices were cancelled because the companies were either out of business or no longer sold products in the state.
- As of the date of this report, five companies had not yet paid the invoice. The total amount of the open invoices is \$2,800.



Goals for FY20:

- If unpaid, send remaining delinquent accounts to state collections.
- Update fee database as invoices are paid.
- Send out 2021-2022 invoices by the first week of October 2021.
- Continue to process and track fee payments (both new and delinquent) as they come in.


SURVEY


As stipulated in SB 820, "beginning January 1, 2014, each county and municipal animal control shelter and each organization that contracts with a county or municipality for animal control shall report quarterly to the department on a form prescribed by the Department describing for the previous 3 months: (1) the number of cats and dogs taken in; (2) the number of cats and dogs disposed of, broken down by method of disposal, including euthanasia; and department describing for the previous 3 months." The following details what the program coordinator did during this reporting period to meet this requirement.


Accomplishments for FY20:

- The program coordinator sent survey data requests to the facilities that responded to the initial survey request sent in February 2014 (covering the October-December period of 2013), and those private organizations that either volunteered to participate or have subsequently received funding from the program, and must provide data as per the terms of the grant agreement.
 - As of the date of this report 31 facilities report shelter data to MDA. Of these facilities, 27 are county-run or county-funded, and four are private operations.
- The program coordinator input all results into a spreadsheet database by organization.
- Analyzed the data for the complete CY14-20. The program appears to be having a significantly positive impact on its targeted metrics of intake and euthanasia. The following graphs show the data that has been collected.
- 2020 saw a significant decrease in animals surrendered to shelters and animals euthanized in shelters. It is unclear how much this was impacted by COVID-19. We are hopeful that 2021 will still trend a decrease from 2019 even if it does not continue to be as low as 2020 was.











Goals for FY20:

- Complete and post the report for each quarter of data submitted in the last two quarters of FY20 and the first two quarters of FY21.
- Create a trend analysis report to be posted on the Spay and Neuter Program website.
