## **Maryland Department of Agriculture Spay and Neuter Grants Program ANNUAL REPORT**

*August 2025 (July 1, 2024 – June 30, 2025)*

This report details the activities and accomplishments of each element pertaining to the Maryland Spay and Neuter Grants Program for Fiscal Year 2025, covering July 1, 2024 through June 30, 2025. This report should be read in full, for complete context.

The end of FY25 marks the close of the 11<sup>th</sup> year of funding for the Spay and Neuter Grants Program. As of June 30, 2025, the program has awarded \$8,820,472.91 to fund 317 projects that have provided 140,590 spay and neuter surgeries for dogs and cats of low-income families, and for community cats.

The Program Coordinator attended several outreach events during FY25, including the Maryland State Fair on August 25; and BARCStoberfest on October 26, among others. These community events are useful not only for promotion, but also for speaking to citizens to learn about the issues that they face as pet owners and animal advocates. Other outreach highlights included tabling at the Governor's Buy Local Cookout in July, which has been helpful with informing farmers and other business owners, as well as legislators and their staff, about our Program.

The Program Coordinator continued to conduct site visits with grantees and potential grantees, and attended PAWS meetings during FY25. This outreach has helped foster better working relationships with the organizations and aids in making them aware of MDA resources. It has given some perspective and a better understanding of the specific needs and challenges in their communities and at their shelters. Lastly, having these in-person meetings has assisted with clarifying policies and procedures, reporting requirements, regulations, etc.

The Spay and Neuter Advisory Board (SNAB) membership remained consistent in FY25, with no changes. In addition to the SNAB's annual meeting in August, the SNAB held two work sessions in October and November 2024, to discuss updates to the Program's applications, instructions, associated materials, and administration. As a result, a number of these changes were made to help ensure the Program continues to meet its intended purpose of reducing intake and euthanasia in Maryland animal shelters.

In FY25, the application process migrated away from OneStop, instead using fillable Word documents for the applications. This was due to the high cost quoted by the vendor for making the changes that would be needed annually, and their inability to meet the Program deadline for making the applications live on OneStop. This was prior to the subsequent changes that took place as a result of the SNAB's fall work sessions, which generated even further edits that would have been needed. Therefore, it was determined that OneStop would not be feasible to use for this cycle.



As reported previously, many projects and their partner veterinarians and agencies continue to struggle with challenges initially brought on by the COVID-19 pandemic. Costs continue to rise, and the national veterinarian shortage is still taking a toll.

In looking at the year-over-year shelter intake and euthanasia statistics, and the charts at the end of this report, you will see a significant drop in numbers between 2019 to 2020 (the height of the pandemic), and then a slow but steady increase from 2021 through 2025. Dog intake in particular, and their subsequent length of stay, has notably increased over the past couple of years. This dip in intakes during 2020 was an outlier year, and shelters are now seeing numbers slightly higher than prior to the onset of the pandemic. It is again worth noting, like last year, that while intakes have increased, euthanasia has not increased at the same rate.



## GRANT PROPOSALS SELECTED

### FY25 Funding Cycle:

For the FY25 funding cycle, MDA received 38 applications, with a combined request of \$1,709,539.00 for 21,240 surgeries. Of those 38 applications, 36 were approved. The grant application acceptance period opened on January 5, 2024 and closed on April 5, 2024. The Spay and Neuter Advisory Board (SNAB) met on August 23, 2024, and selected the following applications to recommend for funding. These recommendations were accepted by the Maryland Secretary of Agriculture, Kevin M. Atticks, on September 11, 2024.

The following table summarizes the funded recommendations provided to the Secretary for approval. They are in order of ranking based on the average cumulative scores by the SNAB.

#### Accomplishments for FY20 Funding Cycle Projects through FY25:

- All 30 of the approved projects have launched.
- 29 of the 30 projects have been completed.
- Of the 29 completed projects, 22 projects (76% of the total projects) either met their target number of surgeries or exceeded their targets, five projects completed over 90% of their target surgeries, one project completed more than 85% of their target number of surgeries, and the lowest performing project completed 77% of their target surgeries.
- The one remaining open project (20-532) has received several grant extensions but to our knowledge has not completed their project. They have been asked to submit reports and return the remaining funds, but to date have not done so. This grant agreement has been referred to the Office of the Attorney General's False Claims Unit to reclaim the \$13,785.00 of unspent grant funds.
- As of the close of FY25, 15,256 of the 15,263 approved spay/neuter surgeries (99.95%) have been completed.

#### Accomplishments for FY22 Funding Cycle Projects through FY25:

- All 35 of the approved projects have launched.
- 34 of the 35 approved projects have been completed.
- Of the 34 completed projects, 25 projects (73% of the total projects) either met their target number of surgeries or exceeded their targets, four projects completed over 90% of their target surgeries, one project completed more than 85% of their target number of surgeries, and the lowest performing project completed 47% of their target surgeries.
- The one remaining open project has received a final grant extension through 12/31/25. At that point they must return any unused funds.
- Two FY22 grantees returned a portion of their funding, after realizing they could not complete the projects, due to staffing issues. The total amount returned was \$9,821.50.





- As of the close of FY25, 14,343 of the 14,446 approved spay/neuter surgeries (99%) have been completed.

#### **Accomplishments for FY23 Funding Cycle Projects through FY25:**

- All 31 of the approved projects have launched.
- 30 of the 31 approved projects have been completed.
- In 2025, the one remaining FY23 active project received a final grant extension through 6/30/25, at which point they have been instructed to return any unused FY23 funds, and start on their FY25 project. In addition, the second allocation for this project was canceled. This reduced their FY23 grant by half; the number of their target surgeries was reduced to 57 surgeries; and their overall grant award was reduced by \$5,700.00. These funds will return to the Spay and Neuter Grant Program's fund balance to use for future grant awards. MDA is expecting to receive a refund from this grantee.
- Of the 30 completed projects, 17 projects (57% of the total projects) either met their target number of surgeries or exceeded their targets, nine projects completed over 90% of their target surgeries, two projects completed more than 80% of their target number of surgeries, and the lowest performing project completed 57% of their target surgeries.
- Four FY23 grantees returned unused grant funds, totaling \$20,237.50.
  - The largest of these refunds was \$18,185 returned by Chesapeake Feline Association. Due to increased costs, and the veterinarian and other staffing shortages, they had to close their Spay & Neuter Clinic in Cecil County in FY23.
- As of the close of FY25, 14,408 of the 14,494 approved spay/neuter surgeries (99%) have been completed.

#### **Accomplishments for FY24 Funding Cycle Projects through FY25:**

- All 32 of the approved projects have launched.
- 31 of the 32 approved projects have been completed.
- The one remaining active project has been completed, but a Final Report has not been received by the Program as of the close of FY25.
- Of the 31 completed projects, 25 projects (80% of the total projects) either met their target number of surgeries or exceeded their targets, and the remaining six completed projects completed over 90% of their target surgeries.
- As of the close of FY25, 14,802 of the 14,590 approved spay/neuter surgeries (101%) have been completed.

#### **Accomplishments for FY25 Funding Cycle Projects through FY25:**

- 35 of the 36 approved projects have launched.
- One project that had not yet started as of 6/30/25 is scheduled to begin on 7/1/25.
- Three of the 36 approved projects have been completed, and final reports submitted, as of the close of FY25.
- Of the three completed projects, two projects either met their target number of surgeries or exceeded their targets.



- As of the close of FY25, 8,030 of the 14,379 approved spay/neuter surgeries (55.8%) have been completed. The remainder of the surgeries are expected to be completed by the end of the grant agreements (December 31, 2025).

**Goals for FY26:**

- SNAB meeting to be held on August 22, 2025 to make funding recommendations from the applications received for FY26.
- Continue visiting grantees, as well as shelters that are eligible to apply but have not done so.
- Solicit applications for FY27 funding beginning in January 2026.

#### Accomplishments by Funding Cycle as of the Close of FY25:

- The cumulative target number of surgeries approved for all 11 funding cycles thus far is 144,453 procedures. At the end of the fiscal year, 140,590 (97%) of the total target number



of surgeries were reported as completed. This number includes active projects that are not yet complete, but does not include reports not submitted as of 6/30/25.

- Of the completed projects (FY15 through FY19, FY21):
  - FY15 resulted in 5,133 procedures out of the 5,340 projected (96.1%)
  - FY16 resulted in 8,267 procedures out of the 8,281 projected (99.8%)
  - FY17 resulted in 13,654 procedures out of the 12,863 projected (106.15%)
  - FY18 resulted in 14,350 procedures out of the 13,973 projected (102.7%)
  - FY19 resulted in 16,940 procedures out of the 16,364 projected (103.5%)
  - FY21 resulted in 15,407 procedures out of the 14,460 projected (106.5%)
- Of the five funding cycles with active projects at the close of FY25:
  - FY20 projects completed 15,256 surgeries (99.9% of the 15,263 goal), with one project still active at the close of FY25.
  - FY22 projects completed 14,343 surgeries (99.2% of the 14,446 goal), with one project still active at the close of FY25.
  - FY23 projects completed 14,408 surgeries out of the 14,494 projected (99.4% of the 14,494 goal), with one project still active at the close of FY25.
  - FY24 projects completed 14,802 surgeries (101.4% of the 14,590 goal), with one project still active at the close of FY25.
  - FY25 projects completed 8,030 surgeries (55.8% of the 14,379 goal), with 29 projects still active at the close of FY25.

**Goals for FY26:**

- Close out the remaining active projects.
- Continue managing the active projects.
- Fund as many projects as fully as possible from the pool of FY26 cycle applications, and manage the FY26 projects cycle.
- Provide oversight for all projects to ensure funds are dispersed to grantees as per each project schedule, that all reports and related project obligations are met, and to offer assistance and guidance to all project managers to help them reach or exceed their goals.



## ***PUBLIC EDUCATION AND OUTREACH***

---

The following summarizes the outreach efforts put forth with regards to the Spay and Neuter Program during the fiscal year.

### **Accomplishments for FY25:**

- The Spay and Neuter Advisory Board met on August 23, 2024 to discuss funding for FY25 projects. The meeting was advertised on the MDA website two weeks prior to the meeting date and posted on Open Meetings.
- The Spay and Neuter Advisory Board met again on October 28, 2024 and November 26, 2024 to discuss changes to the applications, guidelines, and program policies in an effort to improve the program's operations. The meetings were advertised on the MDA website two weeks prior to the meeting dates and posted on Open Meetings.
- Other program announcements were made on the department's website, on MDA's social media accounts, and on the program webpage.
- The program webpage is located on the department's website and is the main repository for all documents, materials, and information relating to the Spay and Neuter Grants Program. The Program Coordinator reviews and audits the webpage throughout the year, and adds updates and additional information and materials as necessary. There were 40,282 unique visits to the Spay and Neuter Grants Program website in FY25.
- Outreach events attended during FY25 include the Maryland State Fair, Governor's Buy Local Cookout, MD SPCA's Pawliday Village, and BARCStoberfest.
- In addition, each funded project performs localized and targeted outreach and education, not only about the services provided through their grants, but important general information about the need and benefits from the spay and neuter of owned pets and community cats, and where to find additional resources.

### **Goals for FY26:**

- Continue to promote the program through all media available, including a focus on messaging via MDA social media.
- Attend as many public events as possible, in partnership with grantees providing programs in the area, whenever possible.
- Look for new ideas and materials to promote the program to the public and potential applicants.



## ADVISORY BOARD

---

The Maryland Secretary of Agriculture appointed the seven-member Spay and Neuter Advisory Board (SNAB) on November 7, 2013. The SNAB is tasked to make recommendations on the program guidelines and regulations needed to implement the state's Spay and Neuter Fund and provide funding recommendations to the Secretary for each funding cycle.

### Accomplishments for FY25:

- During May through August of 2024, the SNAB carefully reviewed all 38 grant applications submitted for FY25 funding. In anticipation of the annual funding meeting in August, each reviewer conducted their independent evaluations and scored the applications via OneStop. These scores were used to rank the applications, to facilitate the discussion, and help the SNAB formulate funding recommendations to submit to the Secretary of Agriculture.
- The SNAB met on August 23, 2024 to discuss funding for FY25 projects. One SNAB member attended virtually, and the rest of the SNAB met in-person at MDA headquarters. The meeting was posted on Open Meetings and the program webpage, two weeks prior to the meeting date.
- The SNAB held work sessions on October 28 and November 26, 2024, to discuss updates to the Program's applications, instructions, associated materials, and administration. Approved updates to the Program include, but are not limited to; a maximum request cap based on an applicant's annual operating budget, requiring all applicants to adhere to a January 1-December 31 timeline (applicants may request a single quarter grant extension subject to program approval), changes to the emergency medical request policy and procedure, changes to allowable and prohibited expenses, removing the Capital Expense Request grant opportunity (the program had only ever received two Capital Expense Grant Applications since inception and only one of them was funded), and establishing that organizations may only apply for one of each type of grant, among others. The work sessions were posted on Open Meetings and the program webpage, two weeks prior to the session dates.

### Goals for FY26:

- Continue to strive for efficiency in the program and the processes.
- Hold hybrid (in-person/virtual) annual meeting at MDA, on August 22, 2025 to discuss and vote on formulating the FY26 funding recommendations to be submitted to the Secretary of Agriculture.



## ***DEVELOPMENT OF PROGRAM ELEMENTS AND MATERIALS***

---

### **Accomplishments for FY25:**

- As noted in previous sections of this report, grant materials were updated pursuant to the SNAB work sessions in FY25, all forms and guidance documents were edited to reflect the same, and the program webpage was updated with these new materials.
- An annual audit of the Program website and its contents was conducted in June 2025. In addition, the website is reviewed and updated as necessary throughout the year.
- An annual reconciliation of reports and other data in OneStop was conducted to ensure data is correct when compared to the Excel data trackers.
- Met with the MEGA Council (Maryland Efficient Grant Application Council) to discuss incorporating the Program into their plans.

### **Goals for FY26:**

- Conduct annual review of all applications, reports, guidance, materials, website/webforms, and systems; update or improve as needed.
- Continue keeping the project website updated with current information.
- Continue to explore and develop new tools for applicants and project managers.
- Continue to work with MEGA Council.



## FEE COLLECTION

---

The program is funded from annual fees levied on manufacturers of all dog and cat feed and treats registered with the Maryland State Chemist Section. The following lists the accomplishments in fee collection during this period. The program invoices registrants for the annual fee during the first week of October, and payments, whether made immediately or any time subsequent to the invoice date, are good only until the following October. The registrants are asked to review the invoice and product list on which the fee was calculated. They were instructed to delete any products no longer sold in Maryland or did not meet the definition of “cat or dog feed or treat” or add any new products that may have been missing from the list.

### Accomplishments during FY25:

- Invoices for the 2024-2025 billing period were sent during the first week of October 2024. Using product and registrant information from the State Chemist Section database, the invoices were created by DoIT, then emailed to the Spay and Neuter Grants Program Coordinator to print, sort, stuff, and mail. Each invoice was sent via first class U.S. mail (unless otherwise requested by the registrant to be emailed) and included an explanatory cover letter, a list of products on which the invoice total was based, and instructions as to where to send the payment.
- The Program Coordinator maintained a program fee Excel spreadsheet that serves as the main repository of fee remittance information. The Coordinator maintained all paperwork pertaining to each paid invoice.
- Formal second notices were sent in January 2025, and subsequent attempts to make contact with delinquent accounts occurred on additional dates by email and telephone.
- Formal third notices were sent via U.S.P.S. certified or registered mail in March 2025 to the remaining delinquent accounts. If still unpaid at the end of July 2025, the accounts will be sent to the State’s Central Collections Unit (CCU).
  - Some of these accounts also owe prior year fees, which have already been submitted to CCU. To date, they have not paid any fees to this Program, but they are continuing to register products for sale in Maryland, while refusing to pay the Spay and Neuter Program Fees. Their unpaid FY25 fees will be submitted to CCU as well.
- The total number of products invoiced was 12,701 for a total of \$1,270,100.00. Of those products, 762 (\$76,200.00) old products were removed. New products added totaled 17 (\$1,700.00).
- As of June 30, 2025, \$1,183,600.00 had been collected, with \$10,400.00 still due from 13 registrants.

### Goals for FY26:

- Continue to attempt to collect the unpaid fees that were sent to the CCU.
- Continue to maintain invoice fee tracking spreadsheet.
- Provide support for pet food registrants regarding the fees.
- Send out the 2025-2026 invoices in the first week of October 2025.



## SHELTER STATISTICS SURVEYS

---

As stipulated in SB 820, *“beginning January 1, 2014, each county and municipal animal control shelter and each organization that contracts with a county or municipality for animal control shall report quarterly to the department on a form prescribed by the Department describing for the previous 3 months: (1) the number of cats and dogs taken in; (2) the number of cats and dogs disposed of, broken down by method of disposal, including euthanasia; and department describing for the previous 3 months.”* The following details what the Program Coordinator did during this reporting period to meet this requirement.

### Accomplishments for FY25:

- At the end of FY25, 33 facilities report shelter data to the department. Of these facilities, 26 are municipal animal services agencies or nonprofit animal shelters that receive either full or partial county funding, and seven are private nonprofit animal shelters that do not receive county funding.
- While agencies saw a significant decrease in the number of intakes and euthanasia at the beginning of the COVID-19 pandemic, unfortunately, starting in FY22 and through FY25, shelters across our state saw these numbers steadily increase. This was expected, as we know that during the onset of COVID-19, shelter intake and euthanasia rates were unusually low for several months. Intake has increased at a rate higher than that of euthanasia.
- The program website was updated with any missing reports and data, and the statistics reporting page was updated with additional information and helpful links.

### Goals for FY26:

- Continue to actively promote animal adoption, spaying and neutering, fostering, volunteering, and helping your local animal shelter.
- When at community events, ensure citizens are made aware of the shelter crisis, and how they can help lessen the burden.
- Maintain good working relationships with shelters, to help them decrease intake and euthanasia.
