**Sanitation Reports:**

Inspectors Pegeen Morgan and Ellen James presented the Sanitation reports performed between February 25th, 2025 and March 21st, 2025. (Report pulled earlier than normal due to ED being at a conference.)

In a motion by Dr. Schmechel, and seconded by Ms. Quimby, the Board voted unanimously to approve the sanitation reports for all hospitals except Veterinary Imaging. Was unable to inspect treatment areas due to radioactive material. Requesting more information and a possible virtual walk through of the treatment areas.

**Miscellaneous:**

- Chapter 8 Regulation Changes -
  - Initial Draft was shared with Cassie Shirk, Assistant Secretary MAICS; Kevin Atticks, Secretary of Agriculture; and Rachel Jones, Director of Government Relations.
    - They support this initiative and agree that we should try to do it as emergency regulations. They feel this is in alignment with the state's initiative to provide support to federally displaced workers.
    - Currently informing inquiries to submit details to the Board for review until the regulations can be updated.
- Inquiry Regarding Pill Scoring and Multiple Patients on Prescription
  - The Board reviewed and approved a draft response.
    - Splitting unscored medications should be avoided because they are not tested for uniformity of dosages.

- Still require a valid VCPR to prescribe to each individual patient.

#### Legislation:

- SB 875 Medetomidine and Xylazine Consumer Protection Act
  - Brief discussion about the bill that would require veterinarians to get certain documentation when selling these products. Appears to have not gotten out of the subcommittee.
- HB0482 - Occupational Licensing and Certification - Criminal History - Predetermination Review Process
  - Likely to pass this year.
  - Requires us to have a process for applicants to request a review prior to submitting a licensing application/fee to determine if an individual's criminal background would block them from obtaining a license. May charge up to \$100 fee for the review (with some limitations for income level).
- Discussion about the status of the Colorado VPA position status from information received at the AAVSB meeting.
  - Working out an accreditation process.
  - AAVSB is looking at an examination process.
  - First students set to start classes in the fall. First graduates in about 2 years.
- Brief discussion about other states licensing requirements for alternative education for RVTs. (Animal Related Sciences).
  - Other states that have alternative pathways don't have the 6 specific courses but instead use an associates degree in animal sciences + experience. This is something to consider when looking at RVT licensing requirements. We get a lot of confusion due to schools having different naming for courses.
