Staff requests the Board's consideration of whether the sale of farm equipment should be permitted at these events as "farm equipment" is not specifically listed in the Foundation Uses policy.

At the April 26, 2016 meeting, the Board made a motion to: "approve a request for a meat shop, and to hold up to 10 major farm-related events per year (auctions for farm equipment and food) to support the meat/farm operation with a limit to one greenhouse used for accessory sales during events." Following the meeting, Ms. Chasse provided the landowner with an approval letter that included the Amish crafts as accessory sales and, thereby limiting the Amish craft sales area to the interior of the greenhouse. On behalf of the landowner, Mr. Norris requested clarification of the letter so that the Amish craft sales would not be considered accessory sales and their sales area would not be limited.
