** If An Emergency, Notify Within 24 Hours of Application (Elementary - Everyone; Middle / High - List & Posting)

+ Posting of a Sign At The Time of Application At the Access To The Property or Area Treated (Elementary, Middle & High Schools)

Posting (In-School) - Primary Entrance or Central Location For Middle & High Schools
